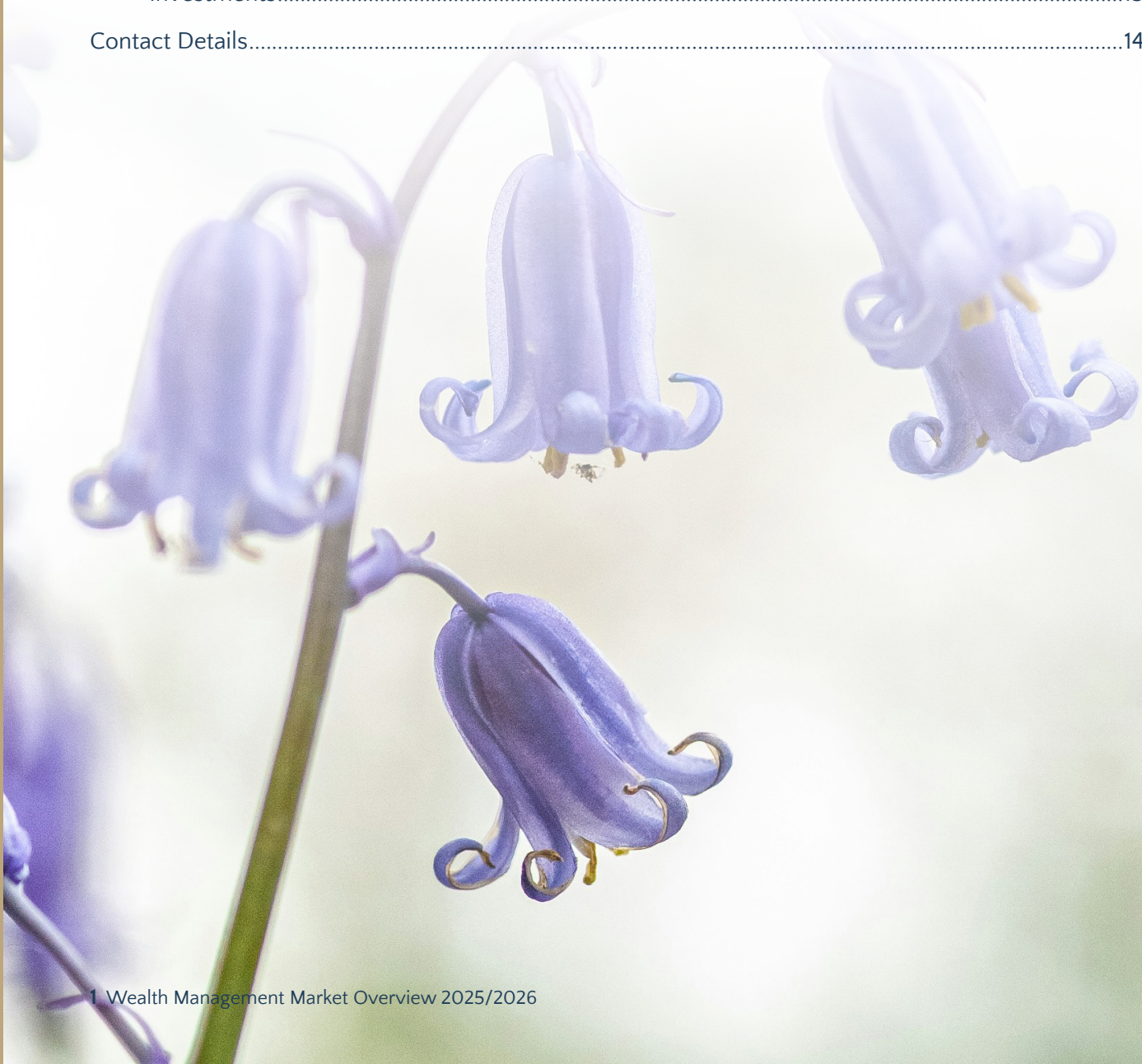

## MARKET OVERVIEW

- Private Client Balanced portfolios averaged a return of approximately 9% during 2025, comfortably above the long-term annualised market return of around 6%. The period from February through April saw challenging market conditions and declines; however, markets recovered steadily through the remainder of the year.
- Senior and strategic hiring across the Wealth Management sector throughout 2025 was influenced by two competing forces. Acting as a headwind to growth was, and continues to be, a challenging political and macroeconomic environment. Across all sectors, organisations are feeling the cost pressures associated with hiring, and it was evident that many Wealth businesses delayed hiring decisions during the year where possible. This was particularly pronounced from September onwards, as uncertainty surrounding the UK Budget weighed directly on activity levels.
- Notwithstanding these challenges, Wealth Management as a sector continues to undergo significant positive change and transformation, as it has for several years. This has continued to drive a meaningful level of senior and strategic hiring activity. Indeed, the recorded volume of leadership movement during 2025 was minimally lower compared with previous years, despite the prevailing headwinds.
- While the final three to four months of 2025 were notably quiet in the pre-Budget period, with many 2026 hiring plans deferred, December saw a clear and distinct pickup in new instructions. This conveyed a sense that, post-Budget, businesses are keen to return to a more proactive stance with respect to their 2026 hiring initiatives.
- The combination of strong investment returns in 2025, a less impactful Budget than initially feared, and ongoing asset flows points towards a relatively busy 2026 in terms of senior and strategic hiring levels.
- Transformation hiring has again been weighted towards the DFM sub-sector, more so than private banks. This reflects the greater degree of change occurring within DFM business models. While most private banks continue to operate with broadly similar business and leadership structures to those in place five years ago, DFM's have evolved significantly over this period.
- With approximately 40 private equity firms invested in the UK Wealth sector, it is unsurprising that the pace of change continues. With a small number of exceptions, the majority of private equity investment and consolidation activity remains focused on firms with sub-£10bn AuA/M, and especially sub-£5bn. Nevertheless, this activity has implications across the wider Wealth sector, with organisations of all sizes observing and learning from both the positive and negative outcomes of this consolidation.
- In general, the prevailing business model within private banks is to employ sales leadership that is distinct from revenue producers. By contrast, DFM's continue to value leadership that combines book ownership and revenue generation alongside team management – effectively “dual-hatting” leadership roles. However, as organisations grow, particularly through corporate activity, it becomes increasingly challenging for individuals to manage headcounts of 50, 100 or more while simultaneously servicing clients and generating revenue themselves. As a result, there is an ongoing trend among larger DFM's to appoint sales leaders who are solely focused on management, despite the additional overhead this creates. These hires are often drawn from private banks, where the requisite leadership experience is more prevalent. We fully expect this trend to continue.



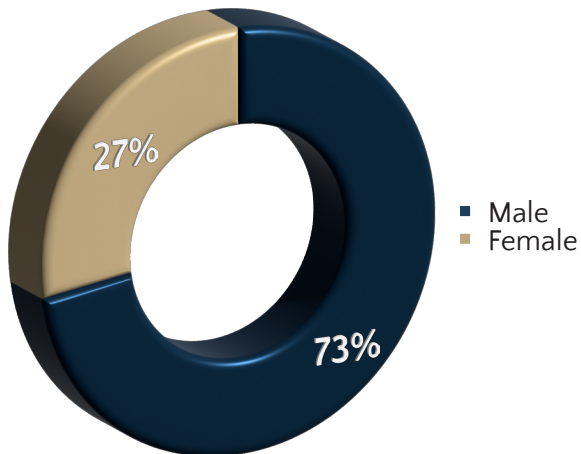
- Consolidation and the resulting rapid growth of organisations have also driven increased demand for strategic functional hiring. Across the C-suite — from CFO and COO to CRO and CCO — many businesses have been required to strengthen executive committee roles by bringing in fresh talent with the skills and experience needed to operate within larger and more complex organisations.
- Much of the consolidation to date has occurred among advice-led businesses, many of which fully outsource their investment requirements or maintain only a small, relatively straightforward in-house investment capability. As these organisations combine, a central component of the business case is often to in-source the investment management of a greater proportion of client assets. This has inevitably led to notable hiring activity across CIO roles, investment strategists and supporting functions. The opportunity to join a small but growing organisation, often with some form of equity participation and a mandate to build an investment proposition from the ground up, can be highly compelling.
- A final observation on consolidation within the Wealth sector is that such activity remains firmly on the regulator's radar. While the FCA is agnostic as to whether consolidation is inherently positive or negative, it is clear about the risks associated with growth that outpaces appropriate controls, governance and a focus on good client outcomes. The regulator has articulated clear expectations around conduct, governance and operational resilience, signalling that consolidators must balance commercial ambition with regulatory discipline. In this context, having a strong and experienced leadership team — from Chair and CEO downwards — is critical.



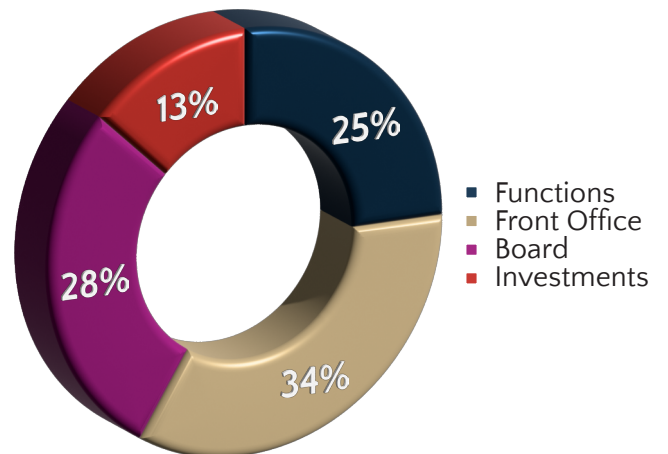

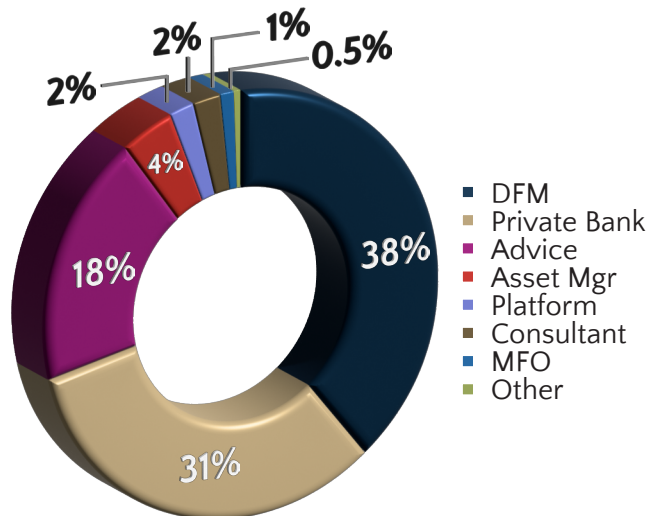
Gender

Hiring by Subsector



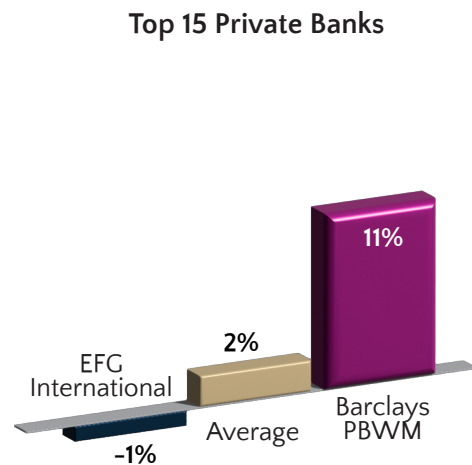
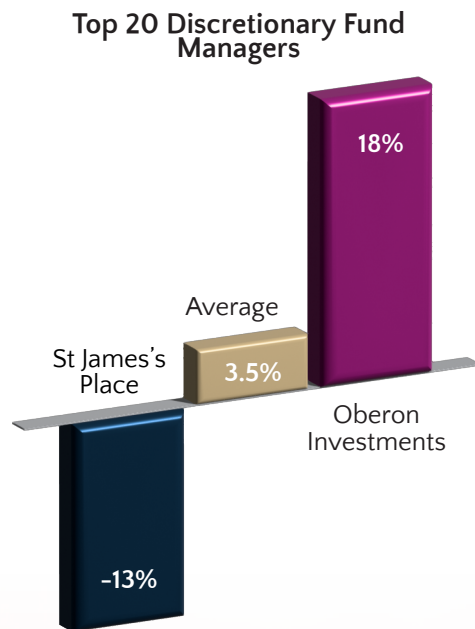

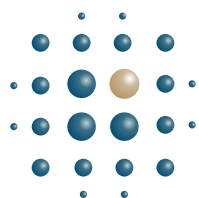
